BACKGROUND AND DISCUSSION:

A General and a Special Municipal Election were held and conducted in the City of Imperial Beach, California, on Tuesday, November 2, 2010.

Pursuant to Resolution No. 2009-6768 adopted June 3, 2009 and Resolution No. 2010-6899 adopted June 15, 2010, the Registrar of Voters of the County of San Diego canvassed the returns of the elections and has certified the results to the City Council of the City of Imperial Beach.

This item is placed before the City Council in order to declare the results of the November 2, 2010 General and Special Municipal Elections. The "Official Canvass" is attached to Resolution No. 2010-6973 as Exhibit A.

RESOLUTION NO. 2010-6973

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF IMPERIAL BEACH, CALIFORNIA, RECITING THE FACT OF THE GENERAL AND SPECIAL MUNICIPAL ELECTIONS HELD ON NOVEMBER 2, 2010, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General and a Special Municipal Election were held and conducted in the City of Imperial Beach, California, on Tuesday, November 2, 2010, as required by law; and

WHEREAS, notice of the elections were given in time, form and manner as provided by law; that candidates were nominated to fill the vacancies as provided by law; that voting precincts were properly established, that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the laws of the State of California relating to general law cities; and

WHEREAS, pursuant to Resolution No. 2009-6768 adopted June 3, 2009 and Resolution No. 2010-6899 adopted June 15, 2010, the Registrar of Voters of the County of San Diego canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as Exhibit A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF IMPERIAL BEACH, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That the whole number of votes (ballots) cast in the precincts except vote by mail voter ballots and provisional ballots was 2,812. That the whole number of votes by mail voter ballots cast in the City and provisional ballots cast in the City was 2,718, making a total of 5,530 votes (ballots) cast in the City.

Section 2. That the names of persons voted for at the General Municipal Election for Mayor are as follows:

Section 5. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates are as listed in Exhibit A attached.

Section 6. The City Council does declare and determine that:

Jim Janney was re-elected as Mayor for the full term of four years ending December 2014;

Lorie Bragg was re-elected as Member of the City Council for the full term of four years for a term ending December 2014;

Ed Spriggs was elected as Member of the City Council for the full term of four years for a term ending December 2014; and

Brian P. Bilbray was elected as Member of the City Council for a short term of two years for a term ending December 2012.

Section 7. The City Clerk shall enter on the records of the City Council of the City a statement of the result of the election, annexed hereto as Exhibit A, showing:

- (1) The whole number of votes (ballots) cast in the City;
- (2) The names of the persons voted for;
- (3) For what office each person was voted for;
- (4) The number of votes given at each precinct to each person; and
- (5) The total number of votes given to each person.

Section 8. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
