CITY OF IMPERIAL BEACH NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City Council of the City of Imperial Beach will conduct a public hearing on Wednesday, October 20, 2021, time specific for 6:00 p.m., and to be held virtually in accordance with California Government Code section 54953(e).

At the meeting, the City Council will 1) receive a presentation on the redistricting process; and 2) conduct a public hearing to receive public input regarding the composition of Council election district boundaries.

All interested persons are encouraged to participate in the public hearing and express opinions or submit information related to this matter. Details on how to participate in the meeting will be on the agenda.

Public Comments: Pursuant to the State law, members of the public will only be allowed to participate in this public meeting electronically. Members of the public who wish to watch City Council meetings, are encouraged to stream from the City website at imperialbeachca.gov/council_meetings. In lieu of in-person attendance and only during the time of the COVID-19 emergency, members of the public can submit their comments on specific agenda items via e-mail at comments@imperialbeachca.gov. Comments will be accepted prior to the City Council meeting and up until the time that the Mayor announces that public comment is closed for the public hearing. Please note in your email subject line the item on the agenda that you wish to comment on and specify if you would like the written comment to be read aloud or just to be entered into the record. Please note that if you request the comment to be read aloud during the meeting, it will be limited to three (3) minutes so that business can be efficiently completed at the meeting.

Providing Oral Comments During the Meeting: To provide oral public comment during the meeting, join Zoom via desktop computer/cell phone app or telephone. Members of the public will not be shown on video; they will be able to watch and listen and to speak when called upon. If you would like to speak on an item, use the "Raise Hand" option on the desktop/phone app or press *9 on your telephone when instructed to do so. Public Comments will be limited to three (3) minutes so that business can be efficiently completed at the meeting.

Information concerning the redistricting process can be found at imperialbeachca.gov/redistricting.

If a person wishes to challenge, in court, any action the City Council may take regarding the subject matter of the public hearing, then that person may be limited to raising only those issues raised at the subject public hearing or in written correspondence timely delivered to the City Clerk at, or prior to, the public hearing.
