I understand that any materials for reuse, recycling or other salvage claimed by me to be salvaged in Mexico, shall fully comply with the requirements of this WMP, the ordinance and any other applicable law, rule, regulation and/or policy. A weight scale receipt issued from a scale (1) within the United States and (2) meeting all regulatory standards per the ordinance, shall be provided for such materials. I am aware that the City may require additional documentation to verify compliance.	
All subcontractors will be informed of and required to comply with the Construction and Demolition Debris Waste Management Plan.
